Financial aid access	Pell, scholarships, grants, TWC	Limited TPEG, few scholarships, TWC
Program length	*1-2 years	3 weeks+
Registration patterns	1-2 semesters prior	The day before class
Cycle of offerings	Semester based	Quarter based; Rolling
Student profile	Have time	Need to get in and out

Data and Reporting

Data entry

- Are there different software systems used? (Colleague, Lumens, Zogotech)
- Is the software capable of differentiating credentials of value and high demand credentials of value?
- What student information is gathered and how? (basic, manual)

Data warehouse


- Who tracks and reports information? (IR, CE)
- Who has access?

Reporting cycle

- If pulled by semester, some summer CE classes may not end until fall

Strategic Communication


Language barrier between credit and non-credit

- Will there be financial aid available for non-credit workforce programs?
- How will HB8 impact our workload?
- Will CEU's count because they are needed to maintain licensure?
- Will CE students receive the same treatment not that credit students already receive?
- What is involved with shared services?
- How was it decided that "funded" CE programs must be a minimum of 80 hours?

Using top-down messaging

Institutional Planning and Sustainability

Business Model:

- Community Colleges to look more like Technical Schools
- CE is break even, credit is not
- No 2 CE departments look the same from college to college
 - A CE program in one school is a credit program in another
- Online providers not reportable

- CE recruits in 1's and 10's ... credit in 100's and 1000's more focused messaging
- Internal marketing
- Relationships with HS counselors and CTE Directors be a part of the dual credit conversations
