While the official deadline for nominations has passed, I would like to remind all members that *nominations can still be made from the floor during the annual business meeting*. Nominations from the floor will be accepted if the nominated individuals meet the eligibility criteria for the respective positions and have provided the necessary letters of interest and support.

The election will take place during the Saturday morning plenary/annual business meeting. Each candidate will be given a strict time limit of 3 minutes to present their speeches. Following the speeches, the voting process will begin. Each college represented at the conference will have one vote per race. Please have your board's voting delegate sign-in at the registration table.

If approved during the meeting, these changes will take effect immediately, with the exception of Section 5.02(9) which will go into effect with the nominations and elections process for the CCATT Board of Directors in 2024.
