The election will take place during the lunchtime plenary/annual business meeting on Friday, September 13th. Each candidate will be given a strict time limit of 3 minutes to present their speeches. Following the speeches, the voting process will begin. Each college represented at the conference will have one vote per race. Please have your board's voting delegate sign-in at the registration table.
