





THE PROJECT, BRIEFLY

IDEAS will expand access to dual enrollment (DE) and improve educational outcomes for students across the country by designing and implementing a groundbreaking model for *Dual Enrollment Hubs* (*Hubs*) that are embedded within community colleges (CCs) and serve multiple high schools (HS)

IDEAS will: 1) provide Hubs with funding and ongoing TA to support their design, launch, and implementation; and 2) generate a suite of tools, resources, and publications to support national replication and adaptation of the model.



Centralized Operations and Staffing **DE HUB** MODEL Advising and **Partnership** Development **Navigation** Services

Dual Enrollment Hubs

Hubs embedded within CCs will function as central service centers for DE by:

- Managing key operational issues—including faculty and course availability
- Development of partnership agreements with HSs
- Partnering with HSs to provide students, especially high-need students, with robust supports, advising, and navigation services.
