

Dr. Mark Escamilla, President & CEO, Del Mar College

Dr. Escamilla has led Del Mar College in Corpus Christi, Texas, since 2008, guiding its growth to three campuses and advancing academic excellence, fiscal responsibility, and strong partnerships with education, industry, and business. A Del Mar graduate himself, Dr. Escamilla is committed to raising educational attainment in the Coastal Bend, expanding access through increased credit enrollment, doubling workforce credentials in five years, and growing Dual Credit offerings to 43 school districts across three counties.

Under his leadership, the College has become a vital workforce partner, providing training for thousands annually. Appointed by the Governor to the Texas Commission on Community College Finance, Dr. Escamilla helped shape the state's new outcomes-based funding model, positioning Del Mar at the forefront of awarding credentials of value that strengthen families and drive the regional economy.

Dr. Escamilla earned bachelor's and master's degrees from Texas A&M University–Corpus Christi and a PhD in educational administration from The University of Texas at Austin, where he was named a Distinguished Graduate of the Community College Leadership Program. He serves on the Legislative and Executive Committees of the Texas Association of Community Colleges, among other educational and community boards.

Augustin "Augie" Rivera, Jr., General Counsel, Del Mar College

Augustin "Augie" Rivera, Jr. serves as General Counsel for the Del Mar College in Corpus Christi, Texas, and is a member of the President's Executive Cabinet. Augie joined Del Mar College's administration in 2015 after more than 27 years of working as a civil trial and appellate lawyer throughout South Texas. Augie's representation of Del Mar College began in 2005, when he was engaged to serve as the external Board Counsel.

A native of Driscoll, Texas, Augie is a graduate of Yale University and Stanford Law School. He was admitted to the Texas Bar in 1988 and is licensed to practice before the U.S. Supreme Court, multiple U.S. Courts of Appeals, and several U.S. District Courts. He is an elected member of the American Law Institute and a Fellow of the American Bar Foundation.

Augie is a frequent speaker on community college board ethics, governance, and free speech, presenting nationally for ACCT, AACC, HACU, and NACUA. A past NACUA board member, he currently serves on the board of the Texas Association of Community College Attorneys, chairs the Texas Board of Law Examiners, and is vice-chair of the Hispanic Lawyers Section of the State Bar of Texas for 2025–26.

Cobby A. Caputo, Partner, Bickerstaff Heath Delgado Acosta LLP



As Commissioner, he heads the Texas Education Agency, overseeing pre-kindergarten through high school education for more than 5.5 million students in traditional independent school districts and public charter schools.

Previously, Morath served on the Dallas Independent School District Board of Trustees for more than four years, focusing on academic improvements. By his final year, DISD saw gains in kindergarten readiness, math proficiency, and graduation rates.

A graduate of Garland High School, Morath earned a Bachelor of Business Administration degree, summa cum laude, from George Washington University in two-and-a-half years. While starting his first company, he taught an advanced computer science class at his high school alma mater and remains amazed at how difficult it is to teach.

Committed to service, Morath has volunteered in schools, juvenile justice facilities, and international missions, including work in India and Mexico. He and his wife, Dr. Laura Vondra, are the proud parents of two daughters and two sons.

Commissioner Wynn Rosser, Texas Higher Education Coordinating Board

Dr. Wynn Rosser is the Commissioner of Higher Education and CEO of the Texas Higher Education Coordinating Board (THECB), providing statewide leadership and overseeing higher education policy and budget for the world's eighth-largest economy. He brings deep expertise in cross-sector collaboration and a strong commitment to THECB's strategic plan, Building a Talent Strong Texas.

Before joining THECB, Dr. Rosser served nearly two decades in philanthropic leadership, including as president and CEO of the T.L.L. Temple Foundation, focused on rural East Texas, and as chief executive of the Greater Texas Foundation, advancing postsecondary access and success. He previously spent 14 years at Texas A&M University in faculty, staff, and senior administrative roles, including as a lecturer at the Bush School of Government and Public Service.

A native of rural Texas, Dr. Rosser holds an associate degree from Kilgore College and bachelor's, master's, and doctoral degrees from Texas A&M University. He is also a nationally registered and Texas state-licensed EMT. He and his wife, both from multigenerational rural families, are raising three children.


Dr. Brenda Kays, President, Kilgore College

Dr. Kays' career as a community college educator in Texas and the North Carolina System spans over 40 years. Before being named the 9th president of Kilgore College (KC) in 2016, Kays served as the 4th President of Stanly Community College (SCC) in North Carolina and is the first woman to have served in both capacities. She earned her Doctorate in Applied Technology, Training, and Development from the University of North Texas. She has a Master's Degree in Counseling from Midwestern State University and is a Licensed Professional Counselor.

Dr. Kays has served in numerous local, state, and national organizations, including most recently the Board of the Southern Association of Colleges and Schools Commission on Colleges Executive Council; Board Chair for the Texas Association of Community Colleges; and Board President for Arts!Longview. Her influence was evident when the Speaker of the Texas House appointed her to the Texas Commission on Community College Finance, whose work led to the historic House Bill 8. Kays is recognized for her skills as a career and technical educator and, in 2023, served as a special advisor to the Texas Commissioner of Higher Education to chart a roadmap for workforce development opportunities and initiatives across the state.
